The Terry Crews Megastar Giveaway Instant Win Game (the "Game") begins on or about 12:00:01 a.m. Eastern Time ("ET") on July 18, 2023 and ends at 11:59:59 p.m. ET on September 5, 2023 ("Game Period"). The Game is intended for viewing and participation by individuals who are legal residents of the United States or Puerto Rico excluding AK, CA, CT, DC, HI, MD, ME, MN, NV, NH, NM NY, OR, RI, VT \& WA) and will be governed solely by the laws of the United States. Sponsor's time clock will be the official clock of the Game.
